

Financial Responsibility

TeleDirectMD | Effective April 16, 2026

This document outlines your financial obligations when receiving care through TeleDirectMD. By proceeding with your visit, you acknowledge and accept the terms described below.

Consultation Fee

The TeleDirectMD consultation fee is **\$49** per visit. This is a direct-pay consultation fee that covers the physician evaluation, assessment, diagnosis, treatment plan, and any prescriptions sent to your pharmacy. The consultation fee is due at the time of the visit.

What Is Included

Your \$49 consultation fee includes:

- Live video consultation with Dr. Parth Bhavsar, M.D.
- Medical evaluation, diagnosis, and treatment plan
- Electronic prescriptions sent directly to your preferred pharmacy
- Follow-up communication related to your visit

What Is Not Included

The following costs are **not included** in the consultation fee and are your responsibility:

- **Prescription medications** — You pay your pharmacy directly for any medications prescribed. Costs vary by pharmacy and your insurance coverage.
- **Laboratory testing** — If lab work is ordered, you are responsible for any associated costs at the lab or testing facility.
- **Specialist referrals** — If a referral is made to a specialist or in-person provider, you are responsible for costs associated with that care.
- **Follow-up visits** — Additional visits are billed at the standard consultation rate.

Insurance Patients

TeleDirectMD accepts **Blue Cross Blue Shield**, **Aetna**, and **UnitedHealthcare** in select states. If you are using insurance:

- TeleDirectMD will submit claims on your behalf.
- Payment of benefits is subject to the terms of your insurance plan.
- You are financially responsible for all charges not covered by your plan, including copayments, coinsurance, and deductibles.
- Please contact your insurer to confirm telehealth coverage and any applicable cost-sharing amounts before your visit.
- Non-covered services will be billed at the cash-pay rate.

Cash Pay Patients

For cash-pay patients, the full \$49 consultation fee is collected at the time of booking or prior to the start of your visit. Payment is processed securely through our HIPAA-compliant payment system.

Cancellation and Refund Policy

Cancellations made at least 24 hours before the scheduled appointment are eligible for a full refund. Late cancellations or no-shows may be subject to the full consultation fee. If TeleDirectMD is unable to complete your visit due to technical issues on our end, you will receive a full refund.
